

Please refer above captioned letters with regard to recommendations of the Council in respect of the following 3 courses of A.N Magadh, Medical College, Gaya:-

- (i) Recognition of MS(OBG & Gynae) qualification for 2 seats under Magadh University
- (ii) Recognition of MD(Pharmacology) qualification for 2 seats under Magadh University
- (iii) Recognition of MD(Anatomy) qualification for 2 seats under Magadh University

In this connection this is to inform that the request of the college in respect of above three courses was also received u/s 11(2) from Arayabhatta Knowledge University, Patna and assessments had also been carried out by the appointed assessors under Arayabhatta Knowledge University, Patna.

In this regard, this is to point out here that in the recommendations letters inadvertently the name of university has been mentioned as Magadh University instead of Arayabhatta Knowledge University, Patna for which inconvenience is highly regretted.

The Ministry was also pleased to issue Notifications recognizing the above three courses vide Notifications dated 23.04.2019, 20.04.2017, 17.02.2017 respectively under Magadh Univesity.

Copies of assessment reports, recommendations letters and Notifications are enclosed herewith for your ready reference.

In view of position explained above, the matter has been reviewed by the Competent authority and it has been decided to request the Central Govt. to issue corrigendum notifications in respect of above 3 courses under Arayabhatta Knowledge University, Patna.
